THE SAFEHOUSES GIVE ABUSED WOMEN AND THEIR CHILDREN EMERGENCY HOUSING IN A SECURE ENVIRONMENT WHILE THEY DETERMINE THE STEPS NECESSARY TO MOVE TOWARD SELF-SUFFICIENCY AND A VIOLENCE-FREE LIFESTYLE. WE PROVIDED THESE FAMILIES WITH ADVOCACY, GUIDANCE, AND SUPPORT SERVICES DURING THEIR STAY WHICH MAY BE UP TO 90 DAYS.
